2020 KLONDIKE KATE AGREEMENT

In consideration of the efforts of the Royal Order of Klondike Kates and the Saint Paul Festival and Heritage Foundation (SPFHF) in operating the Klondike Kate Pageant and subsequent events, I hereby expressly agree as follows:

1. I agree to use the accompaniment provided by the Royal Order of Klondike Kates during the Pageant and all subsequent appearances and performances.
2. The Royal Order of Klondike Kates and the SPFHF may use my name and/or picture in connection with any Klondike Kate appearance and performance that is connected to the Saint Paul Winter Carnival.
3. If selected, the Royal Order of Klondike Kates and the SPFHF shall have no duty or responsibility to make payment to me or any accompanist required as part of my act in the performance of my duties as Klondike Kate 2020. Any accompanist furnished by the Royal Order of Klondike Kates shall be funded by the Royal Order of Klondike Kates.
4. I will be available to perform all of the duties of Klondike Kate 2020 during the entire term (two weeks) of the Saint Paul Winter Carnival. This will include performing at the Klondike Kate Cabaret and being presented at the Royal Coronation, as well as various requests made for appearances during this time.
5. If selected, throughout the rest of my reign as Klondike Kate 2020, I will assume the responsibility to work in conjunction with the Royal Order of Klondike Kates Coordinator and the appointed Mentor to schedule appearances at other events, according to my availability.
6. If selected, I will receive a copy of, and read thoroughly, the Protocol and Bylaws of the Royal Order of Klondike Kates and willingly abide by them.
7. During my reign as Klondike Kate 2020, only fees established by the Royal Order of Klondike Kates will be charged for any appearances I may make as Klondike Kate 2020.
8. During my reign as Klondike Kate 2020, I understand that all the Royal Order of Klondike Kate appearances, functions, meetings or rehearsals take priority

over Saint Paul Winter Carnival Royal Family or Vulcan Krewe appearances or functions. I will make every effort to attend the Royal Order of Klondike Kate appearances, functions, meetings or rehearsals on those occasions when there is a conflict in scheduling events simultaneously between groups.

9. After my reign as Klondike Kate 2020 is complete, I agree not to perform under the name of Klondike Kate or any variation thereof, for profit unless said performance is in conjunction with, and under the policy and bylaws of, the Royal Order of Klondike Kates. I fully understand that ownership of the name "Klondike Kate" belongs to the Royal Order of Klondike Kates.

10. I agree to indemnify and hold harmless the Royal Order of Klondike Kates and the SPFHF and its agents and employees from all claims, damages, losses and all incurred expenses arising out of my participation in the Klondike Kate pageant and subsequent appearances and performances.
